**Call To Order**

Chairperson Inga Cushman called the March 15, 2021 meeting of the Story Gardens Subcommittee to order at 5:17 p.m.

Larry Laehn, Assistant Library Director Jayme Anderson, Library Board President and Parks & Recreation Commissioner Annette Smith, Parks & Recreation Commissioners Karen Reed and Lee Ann Hare, Historic Preservation Commissioner Leah Kinmonth, and Barb Braun.

**Approve Agenda**

B. Braun motioned to approve the agenda. Comm. Reed seconded, and the motion carried.

**Approval Of Minutes - January 18, 2021**

Comm. Reed motioned to approve the minutes. B. Braun seconded, and the motion carried.

**Discussion And Possible Action On Entrance Archway Art Piece**

The subcommittee discussed the project and the timeline. The subcommittee requested Chairperson Cushman send an email to the three artists the subcommittee has been in contact with letting them know an official decision will be made in May after hearing on the Creative Communities Program grant application.

**Discussion And Possible Action On Outdoor Programming Space**

Director Kunkel and Chairperson Cushman discussed the construction of the outdoor programming space. They will be reaching out to groups and individuals to see if they are willing and able to assist. The high school construction program will not be able to complete the whole project due to the size and scope.

**Discussion And Possible Action On Update To Story Gardens Site Plan**

The subcommittee discussed updates to make to the site plan based on decisions the subcommittee has made on the project in the last few years.

**Discussion And Possible Action On Fundraising Initiatives**

**a. Greeting Cards**

Director Kunkel provided an update. The greeting cards are now back at the library being sold. She thanked Dave's Ace Hardware and Red Rooster for their assistance in selling the greeting cards. About \$200 has been raised so far. The library will be holding a youth design contest to add another option to the greeting cards.

Comm. Reed and Chairperson Cushman will have a table set up at the library's Food Truck Rally on May 2, 2021 to sell the greeting cards and provide additional information about the project.

**b. Online Merchandise Store - March 22-April 19, 2021**

The online merchandise store is set to go live on March 22, 2021 and close on April 19, 2021

**c. Pennies For The Pathway**

Director Kunkel stated Milton's elementary schools and Northside Intermediate School will be holding a penny war the week of April 12, 2021 to benefit the Story Gardens project, specifically the pathway.

**d. 100 Women Mailing Campaign**

Director Kunkel discussed her idea of completing a mailing campaign for the project. She will develop a draft letter for the subcommittee to review next month, and have it mailed out in May. The subcommittee will need to decide how the group will be recognized in the garden.

**e. Milton Fund Grant**

Comm. Smith motioned to direct staff to apply for a Milton Grant to help fund a portion of the entrance archway art piece. Comm. Hare seconded, and the motion carried unanimously.

**f. AARP Community Challenge Grant**

Comm. Reed motioned to direct staff to apply for an AARP Community Challenge Grant to help fund the perimeter walkway. B. Braun seconded, and the motion carried.

**g. American Family Insurance Dreams Foundation Grant**

Comm. Hare motion to direct staff to apply for an American Family Insurance Dreams Foundatoin Grant for Story Walk Signs, and, if the subcommittee can apply for two, the Outdoor Programming Space. Comm. Kinmonth seconded, and the motion carried unanimously.

There were no general items.



Director Kunkel invited the subcommittee members to volunteer to assist with prepping the pollinator garden for the spring/summer seasons on March 31, 2021.


