- Temporary Class "B" (beer) and "Class B" (wine) licenses are available to bona fide clubs, churches, Lodges/Societies, Veteran's Organizations, local chambers of commerce and similar civic or trade organizations, and Fair Associations only. Being a non-profit company is not enough.
- At least one licensed operator (bartender) must be present.
- The fee is \$10 for beer and/or wine. If you have more than one day, they must be consecutive dates.
- **This application must be submitted a minimum of 30 days in advance of the event (Sec. 14-315).**
- If your plans include using the street for your event, you will need a Street Use Permit and you must apply at least 30 days before your event.
- Please contact the City Clerk for additional information.
