Petition Timeline / Milestones



3/18/21	Initial discussion between Town of Milton’s Bryan Meyer and EFPD’s John Sherman
3/24/21	EFPD Special Meeting – Bryan Meyer expresses interest in the Town of Milton joining the EFPD
3/26/21	Jeff Klenz (Harmony) reaches out to Chief Pickering, expresses interest in joining discussions
4/1/21	Current EFPD District Agreement shared with potential petitioning municipalities for their review
4/8/21	EFPD Board authorizes staff to enter into preliminary discussions with the Towns
4/28/21	EFPD Commissioner Evan Sayre meets with representatives of the City of Milton
5/20/21	Towns of Milton-Harmony-Johnstown-Lima meets with 5-Bugles to plan new Milton fire station
8/2/21	Multi-Towns meeting to review proposed 4-Towns Petition to join the EFPD
8/5/21	Chief Pickering meets with Mayor, Administrator and Finance Director from the City of Milton
8/9/21	Chief Pickering meets with Attorney Michael Oellerich to review draft Towns’ Petition
8/12/21	“Procedure to Address Petition for Membership to District” developed by EFPD Legal Counsel
9/21/21	The City of Milton City Council votes to enter into discussions with the Towns about joining EFPD
10/18/21	City and Towns’ Legal Counsels meet to incorporate all five entities into a single Petition and IGA
10/30/21	Final agreement reached between City and Town of Milton on all provisions of the Petition
11/23/21	City of Milton contracts with 5-Bugles to develop designs for a proposed “Milton-West” station
12/15-22/21	City of Milton and Towns of Harmony, Johnstown, Lima, and Milton approve filing petition
1/10/22	Chief elected officials of petitioning municipalities hold a joint press conference
1/12/22	Chief elected officials of petitioning municipalities formally present their petition to the EFPD
3/9/22	EFPD District Board completes review of the Petition and Petitioner’s IGA
4/14/22	EFPD District Board finalizes Staff Report and approves release of the evaluation
4/28/22	EFPD District Board holds joint Information Session for existing EFPD municipality officials
	Legal Counsels for the EFPD, City of Milton and Towns meet to develop draft 10-municipality IGA
	Review of proposed 10-municipality IGA by all municipalities/input obtained/document updated
	Potential action by all 10 municipalities that would be part of the new IGA
	If the IGA is approved, service transition plan and implementation plan developed
	Potential Meeting of Electors held by the Towns of Harmony, Johnstown, and Lima
	Potential referendum by the City of Milton and Town of Milton
